Terms & Conditions of Membership

1. Acquisition and loss of membership

- 1.1. Supporting Members of the Global Observatory for Gender Equality and Sport (the Association) may be any public or private organization wishing to support the achievement of the aims set out in Art. 3 of the Articles of Association, or who have demonstrated their attachment to the aims of the Association through their actions and commitments.
- 1.2. Every member commits to giving the relevant information and electronic file he/she would like to have on the Association's website. Information, including the logo, published on the website is agreed upon by both parties.
- 1.3. Members can modify their data at any time by sending an email to info@genderequalityandsport.org.
- 1.4. Members commit to updating their data on a regular basis.
- 1.5. The Association commits to providing its member list on its website.
- 1.6. Applications for admission are addressed to the Association's Board. The decision to accept an Advisory Council Member falls within the exclusive and discretionary competence of the Association's Board. The Association's Board decides whether to admit new members and informs the General Assembly accordingly. If the Association's Board decides to turn down an application for membership, it does not need to justify its decision.
- 1.7. Membership is terminated:
 - by dissolution in the case of legal entities.
 - by written resignation addressed to the Association's Board at least three months before the end of the financial year.
 - by exclusion pronounced by the Association's Board, for "just cause", with a right of appeal to the General Assembly. The deadline for appeal is thirty days from notification of the Association's Board's decision.

In all cases, the annual membership fee remains payable. Members who resign or are excluded have no right to the Association's assets.

1.8 Exclusion of Member liability:

- The Association's assets alone are liable for commitments entered into in its name.
- All personal liability of its members is excluded.

2. Financial conditions

- 2.1. The financial year begins on 1 January and ends on 31 December each year.
- 2.2. The membership fee is due for the entire financial year, regardless of the contract signing date.
- 2.3. The yearly fee is as indicated on the membership application form.

3. Members' rights and benefits

- 3.1. Please see the detailed list of *Members' rights and benefits* annexed.
- 3.2. All members are associated with the Association by the official designation "Advisory Council Member" and are entitled to use their "Member" label.
- 3.3. Advisory Council Members of the Association will not in any case be entitled to be directly associated with one or with all the founding members of the Global Observatory for Gender Equality and Sport.
- 3.4. Reproduction rights of the Global Observatory for Gender Equality and Sport logo.
